Skiing Burke Mountain in Vermont offers a more intimate and authentic experience compared to larger resorts. ## Lodging:

The club will be staying at the Burke Mountain Hotel and Conference Center. The hotel offers the convenience of ski-in/ski-out access for those looking to maximize their time on the slope. Hotel amenities include rooms with kitchenettes, complimentary Wi-Fi, fitness center, and ski rental and repair. On mountain food options include The View Pub and Main Lodge Cafeteria for full service, and Bear Essentials found on the first floor of the hotel for grab and go items.

- 1. Prices are based on double occupancy. An additional individual in a room without notifying the club in advance is prohibited. Should the club and/or hotel become aware that an additional individual is in the room the responsible club member will be liable for any additional room fees. These fees will be paid to the hotel prior to checkout using the credit card provided at check-in.
