Skiing at Killington, Vermont offers a diverse range of trails, stunning mountain views, and the longest ski season due to its extensive snowmaking. It's one of the largest ski areas in the Eastern US, offering a variety of terrain for skiers and snowboarders of all levels. The resort also has a vibrant après ski scene, making it a popular destination for winter sports enthusiasts.

Lodging:

The club will be staying at the Cascades Lodge. The hotel is a short drive to various base lodges. Or if you don't want to drive take a free shuttle bus or short walk to the Snowshed Lodge. Amenities include indoor pool, sauna and hot tub, free Wi-Fi and relax after a hard day of skiing at their cocktail lounge.

Trip Regulations

1. Prices are based on double occupancy. An additional individual in a room without notifying the club in advance is prohibited. Should the club and/or hotel become aware that an additional individual is in the room the responsible club member will be liable for any additional room fees. These fees will be paid to the hotel prior to checkout using the credit card provided at check-in.
