Registration and payment Policy

Mammoth Mountain Ski Area is a large ski resort in the western United States, located in eastern California along the east side of the Sierra Nevada mountain range in the Inyo National Forest. The resort has more than 3,500 acres of skiable terrain which is serviced by 28 lifts. The area has 3,100 ft of vertical, and has a summit elevation of 11,059 ft. The ski area is located on the north side of Mammoth Mountain in the volcanic Long Valley Caldera. The top of the mountain has challenging chutes and groomed as well as mogul runs. There are eight Unbound terrain parks. Unbound Main, adjacent to Main Lodge, is highly praised by extreme snowboarding and skiing enthusiasts, and is one of the major attractions of the ski resort. Mammoth Mountain also has one of the longest ski seasons in North America, which averages from the start of November to Memorial Day. The resort occasionally enjoys a longer season, as in 2016/2017, when it opened on November 8th and did not close until August 6th. The 1994–95 season was Mammoth Mountain's longest, with the resort operating over ten months from October 8 until August 13. The 2016–2017 season was the third snowiest on record, with 618 inches (2010-2011 with 668.5 inches was the second snowiest, and the current 2022-2023 season total holds the record with 715 inches so far at the main lodge, and nearly 900 inches at the summit. January 2017 was the snowiest month in Mammoth history, with 246 inches. Mammoth receives an average of 290 inches (740 cm) of snow per season.

For our trip, we will be staying at the Mammoth Mountain Inn. Set steps from the ski gondola at an elevation of 9,000 feet, this cozy mountain lodge is 4.8 miles from the town of Mammoth Lakes. The inn offers warm, traditional lodge rooms and condos. All come with high-speed Internet access, TVs with satellite channels, iHome docks and coffeemakers. Condos also have kitchens or kitchenettes. Amenities include an underground parking garage, a fitness center and a business center, along with a game room, a heated outdoor pool and a hot tub. There's also an American bar and grill restaurant serving breakfast (fee), plus a dinner menu specializing in steaks and seafood.

Trip Regulations
